

Graduates from all disciplines are able to undertake practical, paid, work experience being responsible for specific projects to benefit their host organisations in Devon and Somerset.

Placements vary in length from 8 - 12 week placements for Graduate Internships to the longer 20 week Graduate Business Partnership placements. Graduates successfully placed on shorter placements are paid £210 a week – free of tax and NI. Whereas graduates on the longer Graduate Business Partnership scheme are paid a minimum of £300 a week, which is subject to tax and NI deductions.

All placements benefit from a Placement Support Day and Final Celebration Event. Graduates on the longer GBP placements benefit from attending a Business Training Course which is designed to assist in their personal development and their work based projects. Placements are often extended beyond the initial period and can lead to permanent employment.




