

University of Exeter - Postgraduate Taught Global Excellence Scholarships 2024/25
****Round 3 – January 2025 entry only****

The Postgraduate Taught (PGT) Global Excellence Scholarships 2024/25 recognise high academic achievement and ambition. The award amounts are £7,500 (Global Excellence) or £3,000 (Global Merit).

These awards are available to International fee status applicants (including any EU applicants required to pay International fees in 2024/25) who already hold an offer to study an eligible PGT (Masters) programme at the University of Exeter in the 2024/25 academic year for **January 2025 entry**.

Scholarships are available for the following campus-based Masters programmes in the University of Exeter Faculty of Environment, Science and Economy:

Business and Management

- MSc Business Analytics
- MSc Business and Management
- MSc International Business and Strategy
- MSc Marketing and Business Analytics

Data Science

- MSc Statistical Data Science

Engineering

- MSc Engineering Business Management
- MSc International Supply Chain Management

Only the programmes listed above are eligible. (Postgraduate Certificates, Postgraduate Diplomas, Degree Apprenticeships, fully online or distance learning programmes are not eligible.)

Scholarship recipients are selected on:

- Academic merit, based on the information applicants have supplied in your programme application. Applicants will typically be expected to demonstrate that they have achieved or are able to achieve the equivalent of UK upper second class degree.
- The ability to demonstrate the following as part of the application process: academic ambition; future career ambitions; a genuine need for the scholarship and how this will support your ambitions; a sense of social responsibility and willingness to engage with the Exeter community.

To apply, you must complete and submit an online application form, via the Funding database entry, including a personal statement of up to 300 words that responds to the following questions:

- What is your interest in your chosen programme of study and what are you hoping to learn?
- What are your future ambitions and how will your studies help you to achieve them?
- What would being awarded a Global Excellence Scholarship mean to you – what difference would it make?
- As a Global Excellence Scholar, how might you act as an ambassador for the University?

You may only make one application to the Global Excellence Scholarship 2024/25 scheme per eligible programme for which you are holding an offer. You should apply at the earliest opportunity following receipt of your programme offer. Duplicate applications will be disregarded.

Application rounds:

Global Excellence Scholarship 2024/25 scheme Rounds One and Two, for September 2024 entry, are closed – no further applications can be accepted, nor awards offered.

Round 3, for January 2025 entry only

Opens: 30 August 2024

Closes: 30 October 2024

Decisions communicated by: 16 November 2024

Applications will be checked initially to ensure that the eligibility criteria have been met. Applications will then be considered by a nominated panel within the faculty. If candidates are unsuccessful for a higher value award, then they will be automatically considered for a lower value award. Applicants will be notified of the outcome of their application by email by the relevant date indicated above.

You cannot receive more than one scholarship from the University of Exeterⁱ; if you are eligible for multiple scholarships, you will be awarded whichever scholarship has the higher value.

If your tuition fees will be financed by an external body (such as an overseas government or Chevening, Commonwealth or a partner Institution) with whom the University has a shared financing agreement then this award may be invalidated or superseded with a different fee arrangement.

If you expect to receive funding from a charity this may also make you ineligible to receive this scholarship.

It is your responsibility to inform us if you are in receipt of any external funding prior to enrolment; please email a copy of the award letter to Admissions: pg-ad@exeter.ac.uk

If you defer your 2024/25 offer or change fee status, then your scholarship offer will be invalidated. In the event that you withdraw or interrupt your studies post enrolment then the University Finance regulations at that date will apply as regards any repayment or other requirements: www.exeter.ac.uk/students/finance/studentfinanceregulations

By applying for this scholarship, you are agreeing to your personal details being shared with the scholarship panel members.

Please note that if you are successful and accept this award, you may be asked to provide a photograph and written or video profile to appear in publicity material relating to scholarships and/or study at the University of Exeter.

This scholarship will be awarded as a reduction of the tuition fees; it cannot be paid as cash or attributed to other charges such as accommodation fees. It will be automatically deducted from your first-year tuition fees following enrolment. If you choose to pay your tuition fees in instalments, the award will be deducted from the total annual tuition fee and the remaining balance split accordinglyⁱⁱ.

This award is for one year only and is not recurrent for subsequent years of study.

***Round 3 Notes:**

- Applicants holding a Postgraduate Taught Global Excellence Scholarship 2024/25 award offer from Round 1 or 2 and changing entry from September 2024 to January 2025 – your award offer remains valid (subject to the conditions in your offer) and you need not reapply in Round 3.
- Unsuccessful Postgraduate Taught Global Excellence Scholarship 2024/25 applicants from Round 1 or 2 changing entry from September 2024 to January 2025 – you are not eligible to apply in Round 3. If, however, you have made a new application for a different eligible programme for January 2025 then you may apply in Round 3.
- You are encouraged to submit your programme application promptly, for the best chance of receiving your admission decision before the scholarship deadline. If you have applied for your programme by 3 October 2024, and responded to any requests for further information, but have not received your decision by 24 October 2024, please contact admissions-scholarships@exeter.ac.uk before the scholarship deadline for advice about applying for this scholarship.

ⁱ A specific exception applies for University of Exeter (PGT) Global Leaders Scholarships 2024/25 for Pakistan, Indonesia, Vietnam, and India, and for the University of Exeter PGT Scholarships 2024/25 for Ghana, Nigeria and Kenya, which can be received together with a University of Exeter Global Excellence Scholarship 2024/25 (£7,500 award only).

ⁱⁱ Tuition fees deduction/s due are applied to your student account and show in your online statement within the first four weeks of study.
