1. CHAIR'S INTRODUCTION

The Chair welcomed Council members to the meeting and noted apologies from Glenn Woodcock. The meeting was the first held virtually by Microsoft Teams and the Chair advised that should members wish to raise questions or comment during discussion of items, to use the Chat facility. Members who wished to raise any questions about items noted under part ii were invited to do so by email and a full written response would be shared with all Council members.

2. MINUTES OF THE MEETING OF 11 DECEMBER 2019 AND MATTERS ARISING

The minutes of the December meeting were approved subject to amendments to the digital measures suggested for the MI Pack and clarification of the Guild's role in the induction process for new students. An update was provided on actions, highlighting that some work had been delayed due to reprioritisation of effort to deal with the response to Covid-19.

i. Students' Guild

The President, Exeter Students' Guild and Chief Executive Officer, Students' Guild, provided an update on progress since the discussion at the last meeting of the Guilds' annual accounts and financial position. It was explained that following the last Council meeting, the University had written to the Guild Trustees and a joint operations group had been established between the Guild and members of the University's senior management to look at what the Guild does. An external review was under consideration and the ongoing internal review process was progressing well. The CEO also notified Council that following receipt of a job offer, he had handed in his notice and the process was underway to look for a new CEO. Interim arrangements were being put in place.

The Registrar added that the University's letter had stated its support for the Guild and an interim substantive replacement for the CEO. It also offered external support to address the issues with the SUSS pension scheme and commitment to participate in the Joint Operations Group.

The CEO and President, Exeter Students' Guild thanked Council for its engagement and support to resolve the issues raised.

3. VICE-CHANCELLOR'S BRIEFING

The Vice-Chancellor provided a briefing to Council on the University's response to the pandemic and its impact on the University and HE sector.

The Vice-Chancellor praised the teams dealing with the response to the developing crisis, noting that enormous amounts of work had been done and expressing huge gratitude to those involved. A summary was provided on the major impacts on recruitment of home and international students for the next academic year and work being undertaken by the University in mitigation, with confirmation given that both the Chair of Council and incoming Vice-Chancellor had been kept informed across developments and were in support of the positions taken.

4. FINANCE

The Chair advised members that a Finance Sub Committee of Council was to be established with the purpose of keeping the cash and liquidity position under constant review. The Committee would review projections under various scenarios and make recommendations to Council on those scenarios. Membership was to consist of the Pro-Chancellors, Nicholas Cheffings and Alison Reed (as Dual Assurance leads for Risk and Finance respectively). Should any other members wish to join, they were advised to notify the Deputy Secretary to Council.

DECISION: Council approved the establishment of a Finance Sub Committee with its Terms of Reference to be presented at the May Council meeting for approval.

The Chief Financial Officer (CFO) outlined the university's financial position, as set out in the supporting papers -

5. <u>USS CONSULTATION (CNL/20/32)</u>

Council discussed the response to the latest consultation and approved the proposed response.

DECISION: Council approved the response to the latest USS consultation on valuation methodology and risk appetite.

6. EXECUTIVE GOVERNANCE (CNL/20/33)

The Registrar and Secretary gave a summary of the new arrangements put in place as mentioned earlier in agenda during the VC's Update. He explained that the accompanying papers described the University's agile response to the Covid-19 and ensuring delivery with alignment with strategic goals.

7. REPORT FROM SENATE

Senate representatives provided a summary from March's Senate meeting, noting a strong emphasis on EDI and the response to staff and students concern about racist incidents. Freedom of speech was also discussed.

8. REPORT FROM AUDIT COMMITTEE

The Chair of the Audit Committee provided an update from March's Audit Committee meeting. He noted that the Committee would be looking at the recommendations made by the Finance Sub Committee ahead of Council's discussion and approval. Discussions on preparedness for the onset of Covid-19, success planning for with KPMG following the retirement of the University's current external audit contact and a future review of insurance arrangements were highlighted as topics of discussion. The Chair also thanked the Vice-Chancellor for his presentation to the Committee and for his preparedness in always in making himself available to the Committee to answer questions and address concerns in an open manner.

9. **DUAL ASSURANCE REPORT**

Due to the meeting overrunning, it was not possible for Dual Assurance leads to provide updates from their portfolios, but the Chair confirmed to members that Dual Assurance meetings should continue to take place and more time would be provided on the next agenda for leads to discuss activities within their groups.
